#### Probable Cause

On 07/22/2023 at 11:30 PM, COLTER A SCHAEFER, (TN DL # 141117157), I have reason to believe, and do believe the defendant mentioned above violated Florida State Statute 316.193(1): D.U.I - DRIVING UNDER THE INFLUENCE Walton County, Florida. Information to support this is as follows.

On 07/23/2023, I arrived on the scene of the crash, located at Watercolor Boulevard East and Western Lake Drive, at approximately 12:40 AM. Sgt. Cary Hurst completed the crash investigation and Mr. Schaefer was informed that he was now being investigated for suspicion of driving under the influence. Mr. Schaefer showed indications of impairment including bloodshot watery eyes, a strong odor of an alcoholic beverage coming from his mouth, and slurred speech.

At 12:55 AM I read Mr. Schaefer his Miranda Rights from a Florida Highway Patrol Miranda Rights card, he declined to answer any questions. Mr. Schaefer chose to participate in Standardized Field Sobriety Exercises (SFSE), results are as follows:

Horizontal Gaze Nystagmus (HGN) - 6/6 clues including; lack of smooth pursuit in both eyes, distinct an sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes. There was no sign of vertical gaze nystagmus.

Walk and Turn (WAT) - 3/8 including; feet break apart during instructions, steps off line, and doesn't touch heel to toe.

One-Leg Stand (OLS) - 1/4 including; swaying.

Mr. Schaefer was asked before Standardized Field Sobriety Exercises (SFSE) if he had prior injuries or leg injuries that could interfere with his balance and he stated he did not. Walton County SO Deputy Kouchnir #318 was on scene for SFSE's and only made observations.

Based on the indicators I observed during the traffic stop and the indicators observed during Standardized Field Sobriety Exercises (SFSE) and the totality of the circumstances I placed Mr. Schaefer under arrest at 1:03 AM on 07/23/2023.

Mr. Schaefer was transported to the Walton County Jail where he was read Implied Consent Warnings at 1:50 AM, he refused to provide a breath sample. Implied consent was once again read at 2:40 AM, Mr. Schaefer still refused to provide a breath sample.
