Please sign the bottom of this document stating that you have read and understand.

1. The Gulf Place Yard Sale takes places on Saturday, February 20th, 2016, from 8:00 a.m. to 1:00 p.m. on the Green at Gulf Place.
2. The event will occur rain or shine.
3. Table registration fee is \$50.00 per table. Tables are 8 ft while supplies last.
4. Payment of space is a commitment for participation.
5. Refunds will not be offered once a space is confirmed, even if we experience inclement weather.
6. Gulf Place will provide 1 - 8' table(s) and 1 chair(s).
7. Setup begins at 6:00 a.m. and must be completed no later than 7:30 a.m.
8. Tables will be assigned by LAST NAME or BUSINESS NAME. Tables are located on the lawn unless otherwise noted. Due to space limitations we ask that you do not move the tables from their original location.
9. All merchandise must be kept within 6ft from the back of your table(s) and two feet from the front of your table(s).
10. Clean up is to begin promptly at 1:00 p.m. and must be completed by 2:00 p.m.
11. Kindly pick up around your space following the completion of the event. Do not leave behind any trash or merchandise.
12. The following items are not accepted at this sale: merchandise that is not authentic, replicas of original products, political or religious handouts, pornographic or nude material and anything viewed by Gulf Place that is not deemed acceptable to a family audience.

13. Vendors are permitted to bring their own tent or umbrella, no larger than 10x10.
14. Please follow all of the guidelines as listed above. If you are unable to follow these guidelines, we will ask the participant to leave and your table fees will not be refunded.
